#### The start of Wilson's Journey - From Distress to Triumph

George Wilson is the owner of a two-family Cambridge home that he bought a little more than 20 years ago. Today, he lives there with his family.

George came to the Home Improvement Program (HIP) in February 2018. During this time, George ran into a number of obstacles. However, HIP program staff kept consistent communication to create a unique plan to meet George's specific project needs.

George qualified for and received HIP's unconventional and affordable program financing to correct health and safety measures and code violations, a lead paint grant to remove hazardous lead, a historic preservation rehab grant, and complimentary weatherization, HVAC systems, and appliances. From there, his HIP journey began.

Change furnace filters, as needed.




Check fire extinguishers.
